Hon'able Vice-Chancellor, on the recommendation of the 'Research Project Committee', has approved the 'Research Proposal' entitled "मराठवाडयातील अभिवादन पध्दती: विशेष मदर्थ नांदेड, लातूर, परभणी व हिंगोळी" in the subject 'History' submitted by you to this university under the 'Minor Research Project' Scheme'. The amount sanctioned to you is Rs. 25000/- (Rupees Twenty five thousand only). The conditions to run the project are as follows:

- ✓ **Research Grant:** The sanctioned Research grant of SRTMU is intended mainly to supplement the research facilities available with the college or campus school.
- ✓ **Preference of Research Heads:** The amount sanctioned is limited to the heads mentioned in your proposal. However, you are requested to inform the preference of different heads under which you will be utilizing the sanctioned amount and submit the details of the head-wise proposed expenditure limited to the sanctioned amount within 'Eight Days' from the date of receipt of this letter. The first instalment will be released only after receipt of the 'Head-wise Proposed Expenditure'.
- ✓ **Date of start:** The scheme is considered to have commenced from the date of dispatch of this letter.
- ✓ **Tenure:** The tenure of a scheme is 1<sup>1/2</sup> years or less as asked for by the investigator. Extension beyond stipulated period shall not be considered.
- ✓ **Research Project Monitoring:-** Research committees of SRTMU will monitor the progress of schemes (through presentation in Mid-Term Review / Project Monitoring Session(s) arranged by BCUD, SRTMU as and when organized.) to ensure that the funds are effectively utilised for maximum results. For this purpose investigators of research schemes are required to submit to BCUD, SRTMU every six monthly comprehensive reports indicating the progress. While the initial report of the first year's progress of work is expected to be brief, 'Final Report' should be sufficiently detailed so as to enable the research committee to review the completion of the 'Research Work' stipulated for the period. Presentation of the progress of the research work through 'Mid-Term Review' is mandatory for the continuance of the scheme.
- ✓ **The 'Six Monthly Progress Report'** in the prescribed proforma and list of equipment purchased from SRTMU grant, if any, should be sent in time so as to reach BCUD, SRTMU on or before 1st of August, 2012. The second instalment of the project shall be released subject to the recommendation of the concerned research committee, based on the evaluation of the progress report during 'Mid-Term Review'.
- ✓ **Utilization Certificate:** Utilization Certificate, duly signed by the 'Principal of the College / Director of the Campus School', must be submitted at the end of the completion of one year.
